Founder's Profile



N J Yasaswy
(1950-2011)

Sri. N. J. Yasaswy (1950-2011), founder of the ICFAI Group of educational institutions and a pioneer in promoting higher education in the private sector had a brilliant academic career: B. Com (Andhra University 1969 – First Rank), CA Inter (May 1971 – First Rank), CA Final (May 1973 – First Rank), ICWA Inter (July 1970 – First Rank) and ICWA Final (July 1972 – First Rank). He was the recipient of the Basu Foundation Award for the Best Student of the Year from both – The Institute of Cost and Works Accountants of India (in 1972) and The Institute of Chartered Accountants of India (in 1973).

During 1974-1980, Sri. Yasaswy was associated with the Administrative Staff College of India as a Faculty Member. In 1981, he started his consultancy firm, Yasaswy Management Association (P) Limited, Hyderabad.

Sri. Yasaswy was appointed by the Government of Andhra Pradesh as Chairman, Andhra Pradesh State Trading Corporation (1985-88), and Vice-Chairman, Public Enterprises Management Board (1986-88). He was a visiting faculty member at the Indian Institute of Management-Ahmedabad (1986-88) and was nominated as a Member on the SEBI Committee on Accounting Standards. He was a member of the Board of Directors of the Association of Certified International Investment Analysts (ACIIA), Switzerland. He authored several books on finance and investments.

Sri. Yasaswy set up the ICFAI Group in 1985 without governmental sops or institutional funding, in an era where government support was the norm. He chose to spend all his energy on the fledgling institution which over the years grew to become a monument to what ambition can deliver. He was instrumental in building several business schools and universities in the developing states of India, particularly in the North-East region. He stood for professional management, excellence in the quality of education offered in the ICFAI institutions, and absolute discipline.

He was charismatic, a great teacher, an institution builder, a visionary and a genius who was years ahead of his time. His vision will continue to guide ICFAI forever.

Infrastructure @ ICAI

The Campus

The campus is set at the foot hills of the Gharwal Mountain Range, amidst a hot bed of bio-diversity surrounded by diverse flora and fauna. This helps the students to forge a symbiotic relation with nature. The campus has separate centers of learning and research for different disciplines.

The Academic Block

The class rooms are adorned with modern theological equipments like LCD projectors and High Definition Sound systems, and are characterized by their scientific seating arrangements. The faculty chambers are suitably equipped to give the student an opportunity to stay in touch with them. The faculty also encourages off class contact with students which helps in fostering strong interpersonal bonds between students and teachers.

Techno-Infrastructure

The University is armed with all modern technologies required for Clinical Legal Education. The campus is covered by Wi-Fi network, which provides 24x7 internet connectivity.

The Library

The Campus has a state-of-the-art Centralized Library for the University along with a specialized Law Library. Both the libraries are fully computerized along with the internet facility. These libraries house vast resources of books,

journals, magazines and periodicals. The students also have access to a vast array of books of other interests such as self help books which are available at the University Central Library. All these facilities make these libraries adobes of knowledge, which quenches the thirst for enlightenment.

Other Activity Centers

There are other centers of activity in the campus too, like the Seminar Halls, Auditorium, Open Theater, and Moot Court Room. Till date these halls have played host to numerous seminars and guest lectures delivered by eminent personalities from different disciplines including the legal fraternity and luminaries.

Procedure for Placement Program PLACEMENT RULES AND REGULATIONS

On Campus & Off Campus placement in ICAI Law School, The ICAI University Dehradun is a facility provided for interested final year students. Students not interested in placements are requested not to register for placements.

ELIGIBLE CRITERIA & PLACEMENT REGISTRATION:

1. All students who expect to be graduated from the institute by the end of the academic year 2024 and are seeking employment until or unless they are debarred to register or have faced DC.
2. Students having less than 6 CGPA [till pre final year] are advised not to register for placement. There should not be any NC/RRA/ Backlog [at the time of registration].
3. Each student should register by submitting the updated resume in the prescribed format along with two PP size photograph in the placement office.
5. Attendance in pre-placement talks, personality development and preparatory classes (including mock interviews) is compulsory for all the eligible students.

RESUME – STUDENT PLACEMENT REGISTRATION

1. Information regarding company visits will be informed through e mail/ notice board. Students are advised to check timely announcements, go through the company website and apply *only if* interested.
2. The details of the resume have to be genuine and any student found violating this, will not be permitted to apply for placements for the rest of the academic year.
3. **Depending on the profile / requirements laid by**

the respective company a detailed resume should be prepared in an attractive manner [as per the specifications of the Placement Office] and submit within the deadline. Late submission will not be considered for the test/interview.

PRE-PLACEMENT INTERACTION (PPI)

1. Those who have submitted the resume and attended the PPI session are eligible to appear in the selection process of that company. The PPI attendance is compulsory.
2. Students must clarify their queries regarding salary break-up, job profile, place of work, bond details, medical fitness requirements, etc with the company officials during PPI.
3. There shall no question about the pay package offered by the company. Students shall not question the policy of the company.
4. The interaction with the representatives of the companies should be in a very dignified manner.

PLACEMENT PROCESS

1. It is the responsibility of the student to check announcements/notices/updated information/ short listed names etc., in the notice boards/email. Students are expected to report at the respective venue as per the announcements.
2. Late comers for the Aptitude Test / Online Test / Interview may not be allowed to appear for the

selection process.

ATTENDANCE AND PUNCTUALITY

1. A student who applies and gets short listed is bound to go through the entire selection process unless rejected midway by the recruiter.
2. Any student who withdraws deliberately in the midst of a selection process will be disqualified from placement for the rest of the academic year.
3. Unauthorized absence for the test/interview will lead to cancellation of registration.

DRESS CODE

Students must be formally dressed whenever they participate in any sort of interaction with a company. The coordinator reserves the right to refuse permission to a student to attend the selection process, if their attire is unsatisfactory. The dress code shall be applicable for Pre placement talks as well.

Boys – Formal dark pant with light colored full sleeve shirt with blazers, neck tie and formal shoes.

Girls – Churidar / Salwar / Shirt-Pant with blazers and formal shoes.

JOB OFFER

1. The Student's Placement Office follows a strict **"One student – One Job Policy"**.
Announcement on the notice board will be considered as the final offer. Offers received from companies must be collected as per timings in circular /notice.
2. The students shall not question the company on why he/she is not selected. Selection is in the hands of the company. Any unruly behavior compromising the reputation of the institute shall deem the student ineligible for future placements and the student shall face the disciplinary committee.
3. The responsibility of going through the offer letter and taking actions therein such as submission of documents lies entirely with the student. The university is not responsible in case the company/firm withdraw the offer and delay/postpone the date of joining.
4. The students should honor the offer and communicate with the Industry in a pleasing manner.
5. In case offers are received directly by the student from the company, the same must be intimated to the placement office.
6. The Wait list will not be disclosed to students and will be released on a per student basis, if necessary.

MULTIPLE OFFERS A student is eligible for only one job. If a student receives more than one offer owing to delays in the

announcements of results by the recruiters, **he/she is bound to accept the job whose results are declared first.** If the results are declared on the same day, the student may choose from the offers in hand and inform the placement coordinator within 2 days of the announcement of the results.

JOINING STATUS Students should notify the company with a copy to the placement office in case they are not joining the company with reasons. For all matters not covered by the above regulations, the placement coordinators will use their discretion to take appropriate decisions. The Placement Cell will not be responsible for any kind of delayed joining offer by the company.

IDENTITY CARD Students must carry their identity cards whenever they undergo a placement process.

1. The Institute reserves the right to change / modify any or all of the above stated Placement rules and procedures whenever found necessary. All changes / modifications will be communicated to the students.
2. Every student has the option of arranging his / her own placement, i.e., opting out of the placement support of the Institute. All such requests must be submitted in writing to the T&P Department before the commencement of the placement process. In case a student would like to withdraw from the Institute's Placement support after the commencement of the Placement Process, s/he may be allowed to do so provided s/he is not amongst students whose interview/ selection process is under progress
3. No Placement Facilitation for a student who:
 - a. Does not attend a process despite nomination having been given.
 - b. Withdraws from the process Mid-Way.
 - c. In the placement process, s/he tells the company that s/he does not want to join them.
 - d. Speaks negatively about the company or ICFAI Law School, Dehradun
 - e. Is found doctoring his/her resume submitted at T&P Department.
 - f. Talks directly to the company representative / executive at any time other than pre-placement talk
