

MEMORANDUM OF UNDERSTANDING

Between

ICFAI University Dehradun, India

&

Rural Litigation and Entitlement Kendra, Dehradun, India

In accordance with a mutual desire to promote activities between ICFAI University Dehradun, India and Rural Litigation and Entitlement Kendra, Dehradun, India agree to the following statements of intent on educational, social and research cooperation.

Cooperation and development of activities may extend to any fields and subjects in which the two institutions may identify shared interests. Cooperation in specific areas may be designed by mutual consent and incorporated into specific additional agreements upon signature by the appropriate University and the authorities.

The two Institutions agree to the following general areas of interest and cooperation:

- The exchange of scholars to conduct research of mutual interest.
- Invitations to scholars and volunteers for participation in conferences, symposia, workshops, projects and camps.
- Exchange of information, academic materials and publication in fields of mutual interest.
- Facilitating the mobility of teachers and volunteers, through exchange and visits between the two institutions.
- To undertake research projects from National and International agencies and mutually work on those projects.


Both parties agree that all financial arrangements necessary to implement this Memorandum of Understanding or any subsequent agreement must be negotiated agreement to the regulations of each institutions and depend on the availability of funds. Both parties recognize that this Memorandum of Understanding establishes a foundation of mutual understanding and interest and does not in itself entail any financial obligations of either Institution. However, the name can be used between the two institutions in light of the Memorandum of Understanding to promote them in their respective areas.


Both the Institutions express their mutual commitment to pursue cooperative educational and social programs and propose in this document to establish mutual linkage, including any required Internship and Placement between ICFAI University Dehradun, India and Rural Litigation and Entitlement Kendra, Dehradun, India.

The two institutions further agree to the following:

1. The agreement begins on November 9th 2020 and is automatically renewed for another year on anniversary of this date. Notwithstanding, either party may, by written notice to the other terminate the agreement effective one year following the date of the notice.
2. Each institution shall name a coordinator who administers and will act as main contact for the other institution. Coordinators shall be the conduits for execution of various programs and activities mutually planned. Coordinators will also maintain records.
3. Each institution agrees to supply regularly to the other and through the designated coordinators, information and material about academic and social activities and requirements for exchange of students and volunteers.
4. Each institution agrees to undertake joint research, surveys, studies and any other relevant programs in the field of shared interest.
5. Each institution agrees to jointly organize academic programs, conferences, seminars, workshops, projects on subjects of shared interest.
6. This agreement may be amended by written approval of both parties if any part of the Agreement be found invalid, all other parts shall remain valid.

This Memorandum of Understanding is being signed and enforced on November 9th 2020, in the gracious presence of Dr. Sushil Kumar Singh, Political Analyst & Writer, Director of Research Foundation of Public Administration, at Dehradun.
