Item 38.12 Modification of PhD Rules & Regulations (Coordinator Ph,D Research to Brief)

The following modifications to Ph.D. Rules and Regulations to be followed in IUD were approved by the Academic Council as well as BOM:

- Doctoral Advisory Committee (DAC) convener and members should have at least four publications in refereed journals.
- The women candidates and persons with Disability (more than 40% disability) may be allowed a relaxation of two years in the maximum duration of Ph.D. Program.
- The women candidates may be provided Maternity Leave/Child Care Leave once in the entire duration of Ph.D. program, for up to 240 days.
- Transfer of women candidates from one university to another university may be allowed.
- Allowable plagiarism percentage should be limited to 25%.
- In accordance with AICTE norms, B.Tech candidates with marks 75% or more should be considered as eligible for admission in Ph. D program.
