Lateral entry to B.Tech Program for Diploma Holders

MHRD is contemplating to link informal skilled education to the formal established higher education programs. In this regard, MHRD has already prepared and circulated, “Document for Credit Framework – Skills and Education”. In times to come, this would definitely provide opportunities to deserving skilled professionals to upgrade their professionalism and acquire a formal approved degree in higher education.

As of now, there exist a number of universities including their affiliated colleges who provide opportunity to engineering diploma holders to get admissions in regular B.Tech programs through lateral entry in semester III. At IUD, it is proposed that such induction of diploma holders could be provided through judicious credit mapping / transfer approach.

The proposal is placed for approval, in principle.

Once the proposal is approved, in principle, Dean, Faculty of Science & Technology, will be instructed to prepare a detailed final proposal. The detailed final proposal of the Dean, FST will be discussed for approval in the subsequent meeting.
