



## **Memorandum of Understanding**

between

**The ICFAI University Dehradun, India**

**&**

**International Engineering and Technology Institute (IETI)  
Hong Kong and Denver, USA**

***[Academic Co-operation]***

## 1. Preamble

This Memorandum of Understanding (MOU) is intended to promote academic co-operation and advancement between:

1.1 The ICFAI University, Dehradun, Uttarakhand (hereinafter referred to as the University) was established under the ICFAI University Act 2003 (Act No.16 of 2003) passed by the Uttaranchal Legislative Assembly and assented to by the Governor on July 08, 2003. Government Gazette, Uttaranchal

The ICFAI University, Dehradun, Uttarakhand is sponsored by the Institute of Chartered Financial Analysts of India (ICFAI), a non-profit educational society established in 1984 under the Andhra Pradesh (Telangana area) Public Societies Registration Act, 1350 F (Act No.1 of 1350F), with the objective of imparting training in finance and management to students, working executives and professionals in India.

The ICFAI University, Dehradun, Uttarakhand is included in the list of universities maintained by the University Grants Commission (UGC) under Section 2(f) of the UGC Act, 1956, vide their letter No. F.9-26/2003 (CPP-I) dated July 22, 2005. The Distance Education Council (DEC) has approved the programs of the ICFAI University, Dehradun.

The Bar Council of India has accorded its approval for imparting three year and five year Law Courses at ICFAI University, Dehradun, Uttarakhand and award degrees in law.

The ICFAI University, Dehradun is Member of the Association of Commonwealth Universities, London and Member of the Association of Indian Universities, New Delhi.

The University has received the approval of NCTE to offer the Bachelors Program in Education through the Faculty of Education. The ICFAI University, Uttarakhand is included in the list of approved institutions maintained by NCTE.

The University believes in creating and disseminating knowledge and skills in core and frontier areas through innovative educational programs, research, consulting and publishing, and developing a new cadre of professionals with a high level of competence and deep sense of ethics and commitment to the code of professional conduct.



A number of educational programs are offered in management, finance, banking, insurance, accounting, law, information technology, arts, commerce, education and science & technology at bachelor's and master's levels on full-time campus and distance learning formats.

The University also allows private candidates to enroll in various programs if they satisfy the eligibility criteria. The University does not provide any courseware, nor conduct any contact classes, nor offer any other support services to private candidates. Such candidates have to prepare for the programs on their own as per the curriculum and are required to attend the examinations, as per the rules and regulations of the University. The University has no study centers/branches outside the State of Uttarakhand. For further details please contact:

## 2. Intent

2.1 Proposals for collaborative work under this MOU will be submitted through liaison officers designated by each institution to assure conformity with the objectives.

2.2 The terms and scope of each proposal will be described in individual contracts.

2.3 The individual contracts will be prepared subsequent to this MOU and signed by both parties and exchanged prior to commencement.

## 3. Objectives and Actions

3.1 The objective of this MOU is to enable both parties to explore and discuss:

3.1.1 Exchange visits of leaders and staffs.

3.1.2 Promote friendship, cultural and educational ties, and to encourage an exchange of ideas and information between the two organizations.

3.1.3 Investigation of possible programme linkages including articulation pathways between the institutions in the future.

3.1.4 Information exchanges on academic developments, teaching methodologies and research activities, including scholarly publications, journals, theses and research activities.

3.1.5 Jointly organized conferences, seminars and workshops on topics of common interest.

3.1.6 Other activities that provide mutual benefits and enhance the operations of both institutions.

3.2 After signing the MOU, the both sides will publish news about their cooperation intentions on their respective official websites.

3.3 The partner will recommend some outstanding colleagues from national and international organizations to be members of IETI.


**4. Commencement and Duration**
