OFFICE ORDER

I am directed to inform you that for consideration of grievance of students at university level a Student Grievance Redressal Committee (SGRC) is hereby created, comprising of the following.

University Grants Commission (Redress of Grievances of Students) Regulations, 2023

1. Students Grievance Redressal Committee (SGRC) as per the UGC Guidelines:

A complaint by an aggrieved student relating to the institution shall be addressed to the Chairperson, Students' Grievance Redressal Committee (SGRC) to be constituted at the level of institution as may be required to consider grievances of the students, with the following composition, namely:

Note:

- i) The term of the Chairperson and members of the Committee shall be for a period of two years.
- ii) The term of the special invitee shall be of one years.
- (iii) The quorum for the meeting including the Chairperson, but excluding the special invitee, shall be three.

(iv) In considering the grievances before it, the SGRC shall follow principles of natural justice.

(iv) The SGRC shall send its report with recommendations, if any, to the competent authority of the institution concerned and a copy thereof to the aggrieved student, preferably within a period of 15 days from the date of receipt of the complaint.
