

# ADMISSION POLICY & SELECTION PROCEDURE

# For Admission into the Ph.D. Program (Full-Time/Part-Time) The ICFAI University, Dehradun

#### 1 Introduction

- 1.1 The ICFAI University, Dehradun (IUD) is established under the provisions of The ICFAI University Act 2003 (Act 16 of 2003) enacted by the State of Uttarakhand.
- 1.2 The University is recognized by the University Grants Commission under Section 2(f) of UGC Act, 1956.
- 1.3 This policy shall be called the IUD ADMISSION POLICY & SELECTION PROCEDURE-2022 (IUDAPSP-2022) for admission to Doctor of Philosophy (Ph.D.) awarded by IUD.
- 1.4 The ICFAI University, Dehradun offers admission into the Ph.D. programme on both the basis i.e. full-time and part-time.
- 1.5 While every effort has been made to ensure that the information contained in this document is accurate at the time of publication, all matters that it covers may be subject to change without notice. IUD reserves the exclusive right to change or withdraw, without notice, any statement in this document.

#### 2 Eligibility criteria for admission to the Ph.D. Programme

The following are eligible to seek admission to the Ph.D. programme in all the schools of IUD (Management, Science and Technology, Law and Education):

- 2.1 Candidates for admission to the Ph.D. programme shall have successfully completed
  - 2.1.1 A master's degree or a professional degree (declared equivalent to the master's degree by the corresponding statutory regulatory body) with at least 55% marks in aggregate or an equivalent grade in a point scale (wherever grading system is followed).
  - 2.2.2 A M.Phil. degree from any recognized university with at least 55% marks in aggregate or an equivalent grade in a point scale (wherever grading system is followed).
- 2.2 Candidates in the final year of their master's programme who expect to complete all their qualifying degree requirements before the date of registration for the first semester of their Ph.D. Programme at IUD can apply for admission. For short-listing purposes, their performance till the preceding semester/year would be considered but their admission would be provisional, subject to their meeting the minimum eligibility criteria after their final qualifying examination results are announced. However, if the student fails in the qualifying examination or fails to produce the degree/provisional certificate/mark sheet within 3 months of the commencement of the 1st semester, his/her admission and registration to the Ph.D. Programme will be automatically cancelled and fee refund will be as per the policy of IUD.

For any other national or international degree, the scale will be interpolated accordingly. An equivalence committee will be constituted by the Vice-Chancellor (VC) to consider applications other than covered under above Clause (2.1, & 2.2). The minimum eligibility criteria indicated above is only an enabling clause. Ph.D. Admission Committee (PAC) constituted by the VC may fix higher criteria at the time of shortlisting keeping in view the number of candidates, minimum background to cope with the program.

Part-time candidates are required to submit a No Objection Certificate on a proper letterhead from the competent authority of the organization in which he/she is presently working clearly stating that the candidate is permitted to pursue Ph.D. on a part-time basis and his/her official duties permit him/her to devote sufficient time for completion of coursework and carry out doctoral research.

#### 3 Intake for Ph.D. Admission 2022-23

The admission into the Ph.D. program will be taken under two categories:

- Category-1: M.Phil. degree holders with 55% marks or JRF/NET/GATE/USET qualified.
- Category-2: Candidates other than Category-1.

The details of school-wise intake for both the categories are as follows:

The intakes shown above are subject to change by the University.

#### 4 Procedure for Admission

- 4.1 The candidates desired to seek admission to Ph.D. Programme at IUD shall apply for the same on the prescribed Application Form by a due date announced by IUD.
- 4.2 The applications will be scrutinized by the Research and Development Cell, IUD under the guidance of Ph.D. Admission Committee-2022 (PAC-2022) constituted by the Vice-Chancellor.
- 4.3 Candidates who belongs to Category-2 have to appear in Entrance Test named 'IUD Research Entrance Test 2022' (IUDRET-2022).
- 4.4 IUDRET-2022 will be an objective type test of 50 questions to be attempted in 2 hours. The entrance will be held offline at IUD Campus only on the prescribed date (tentatively first week of July).
- 4.5 Qualifying marks in the entrance test (IUDRET-2022) will be 50%. If a candidate fails to obtain the qualifying marks, he/she will not be called for interview.
- 4.6 After the IUDRET-2022 written test, list of shortlisted candidates for the interview for both the category will be displayed on IUD website.

- 4.7 An interview/viva-voce for both category will be organized by the IUD wherein the candidates are required to discuss their research interest/area through a presentation before a duly constituted committee. Interview will be conducted on the prescribed date (tentatively third week of July) at IUD campus only.
- 4.8 The selection of qualified candidates will be based on interview/viva-voce for Category-1 whereas for the candidates who have qualified the IUDRET-2022, the selection will be evaluated on the following criteria:
  - IUDRET-2022 Marks 50
  - Academic Performance- 25 and
  - Interview- 25
- 4.9 Academic Performance will be calculated using the following formula:

Academic Performance = [10\*(% in UG)+15\*(% in PG)]/100

Equivalent formula will be used to calculate academic performance wherever grading system is followed.

- 4.10 Merit list for both categories will be separately published on IUD website.
- 4.11 In case of an unfilled vacancy in either of the category, candidates from another category can be requisitioned to fill up the vacant slots, in the order of merit in the second phase.
- 4.12 The last date of fees submission is taken as last date of admission in the Ph.D. Programme.

# 5 How to Apply

A candidate seeking admission into the Ph.D. program can apply offline only. The applications form can be obtained from the Office of Research and Development Cell, IUD up to the last date for submission of forms specified in the Section-10.

# 6 Application Fee

- 6.1 An application fee of Rs. 500/-is required to be submitted along with completely filled application form and self- attested photocopy of supporting documents.
- 6.2 The fee should be paid in cash at IUD campus or through DD in favor of 'The ICFAI University, Dehradun Fee Collection A/c' payable at Dehradun.
- 6.3 Before filling the application form, candidates are advised to read the following carefully: Vacant Seats, Admission Procedure, Eligibility Criteria, IUD Ph.D. Guidelines-2022 available on the link: https://www.iudehradun.edu.in/phd-program.html .

In no case, application fee will be refunded.

- M.Phil./JRF/NET/GATE/USET Certificate (if any)
- NOC from the competent authority (original) for part-time Ph.D.
- Migration Certificate (at the time of admission)
- Character Certificate (at the time of admission)
