77.07 Analysis of Result

77.08 Approval of Full Semester Internship Programs – ICFAI Tech School

The Board discussed the proposal to allow the Full-Semester Industry Internship option for the last semester of the following programs:

- Bachelor of Computer Applications (BCA)
- Bachelor of Science in Data Science (B.Sc. Data Science)
- Bachelor of Science in Mathematics (B.Sc. Mathematics)
- Master of Computer Applications (MCA)
- Master of Technology (M.Tech.)

The Board encouraged the proposal, recognizing the potential for enhancing students' practical experience and industry readiness. Students will have the option to choose between a full-semester industry internship or a set of subjects with projects, as outlined in the existing program structure.

Additionally, the proposal to discontinue the Diploma program starting in 2025 was approved by the Board. This decision aligns with the strategic direction of the institution to focus on enhancing and expanding degree programs.

77.09 Approval of Format of Ph.D. Provisional Degree Certificate

The format of Ph.D. Provisional Degree Certificate was presented to the Board for approval and the Board considered the format of the Ph.D. Provisional Degree Certificate and resolved to submit to the Board of Governors for its approval.

77.10 Faculty Profile

The Board noted the presented school-wise faculty profiles. The University is actively engaged in ongoing efforts to enhance the faculty cadre ratio, demonstrating a commitment to academic excellence. The Board expressed its satisfaction.

77.11 Status of Ph.D. Students

The Research Coordinator informed the Board about the status of research activities undertaken by the University. He informed in detail the publications by the Faculty and Research Scholars, number of Ph.D. Scholars (Full time/ Part Time) and the status of Ph.D. admission for the academic year 2024-25. The Board suggested checking the duration of Ph.D. scholars who have been registered for six years or more and taking necessary actions as required.

77.12 Status of Placements (AY 2023-24)

The Chairperson informed the Board that the highest placement package of IBS in Academic Year 2023-24 is 36.75 LPA, marking a significant achievement for the University. Additionally, the average CTC (in lakhs per annum) has also seen an increase this year. Furthermore, it was highlighted that an ILS student was successfully placed in a US-based company, showcasing the global opportunities available to students. In ITS and IEd.S, students have received preplacement offers and are currently undertaking internships in the same companies, indicating the effectiveness of the University's career development initiatives. The Board members congratulated the chairperson and the team for these achievements.

77.13 Program Promotional Activities for the Academic Year 2024-25

The Marketing Head briefed the Board on the admission status for the academic year 2024-25, highlighting that the projected admission target for all programs at IUD is set at 900.

The Board extended their congratulations and best wishes for the upcoming admission session in 2024.

new binary accreditation system, particularly addressing sustainability outcomes and green initiatives, and reflects the University's commitment to continuous improvement and environmental stewardship.

As part of this initiative, the University has received seed funding of INR 50,000 (1st installment) from the Ministry of Education (GOI). The Board appreciated the same.
- iii) The Chairperson informed the Board that The ICFAI School of Pharmaceutical Sciences (ISPS) has received approval for 100 seats in the B.Pharm program from the Pharmacy Council of India (PCI) for the admission session 2024 -25.
