Report of the Anti Ragging Committee

The Anti Ragging Committee of The ICFAI University, Dehradun have received a complaint of ragging from a student of ICFAI UNIVERSITY on 18th September 2018 vide **Ref No. ARCC/ UK-4785**. The same day i.e. on 18 Sept.2018 University authorities determined it be a case of teasing and directed the complainant to proceed to file a First Information Report (FIR) before police station relating to Injury to body. The committee have identified & counseled the victim so that he feels safe and knows that authorities are with him & action will be taken on his complaint.

The fact of the case mentioned in the complaint of victim is about ragging done by accused student of B.Tech 4th year, Ankur Chauhan and Pratyush, who have been constantly stalking his girl friend xxxxxxx of B.B.A. LL. B (Hons.) (Batch 2016-21). On 18th of September when victim was sitting with his girl friends in the canteen, accused was continuously stalking at her. After a while, accused came to victim where he was sitting and pinched victim cheeks and was about to hit him back again when his other girl friends stopped him. Then again he came around outside to his class and started to pass threats that he will beat him up whenever possible. Then during the lunch time when victim was standing with all of his girl friends in a nearby shop, he came along with his other friends and started beating victim with chairs and other equipments in hand, his others friends were along with him. Also smashed his bike keys and threatened victim by saying that he will kill him and beat victim whenever he will find him. Victim wants immediate actions to be taken against him. It is for the safety of victim and his girl friends.

The committee have listened the views and grievances of victim. We have examined the letter of complainant regarding the issue of fight among students dated 18 sept.2018, OPD description, Medical Report (Medical Opinion-injuries are caused by hand and blunt object, Injuries are simple and one can be described after X-Ray). The statement of the victim in his own handwriting was received. The accused was called before anti ragging committee. He was examined and counseled. He apologized and assured not to do the same thing in future. The accused's friend was also called and examined and counseled. He apologized and assured not to do the same thing in future. The accused and his friend gave their written statement before the committee. The girl friends of the victim present on the day and date of incident were called and examined and counseled. They submitted before the committee their statement in writing and told that accused was teasing them and thereafter the victim intervened by moving to his chair towards accused. Accused provoked by the smile of victim and it resulted in fight outside the campus. Accused with his friends beat victim outside

the campus of ICFAI University. The girl students told to the committee that it is not a case of ragging but a case of fighting between students. The witnesses also told to settle the matter with compromise and submission of apology letter by accused.

CONCLUSION

On the basis of fact and circumstances, it has been decided by the anti ragging committee that it is not a case of ragging, but a case of teasing which converted into fight between students. The matter has been shifted to the Proctorial Board and Disciplinary committee of ICFAI University, Dehradun for strict disciplinary action against accused students of B.Tech. Final year. The copy of statements of victim, accused and his friend, witnesses is enclosed. The copy of written complaint, medical prescription, medical report is enclosed.
