1. Compliments by Chairperson

2. Presentation of Action Plan of IUD Centers by Centre Heads.

All Center Heads presented their plan of Action for the year 2021. They informed the activities to be undertaken by their Center with their tentative dates. The Center Heads explained the activities already conducted, their objectives and outcomes.

The salient points presented by the Center Heads are as follows:

- The IUD Centre for Centre for Environment Law ,Policy, Education and Development(CELPED)
 - The Centre Head informed that CELPED has collaborated with the Environmental Law Education, Research and Advocacy (CEERA), NLSIU Bangalore and has signed an MOU's with them. The Center will conduct a activities under the guidance of Prof. (Dr.) M. K. Ramesh (Chair Professor, MHUPA Chair on Urban Poor and the Law Coordinator, Commons Cell)
- The IUD Cyber Law Cell
 The Centre Head informed the members that an MOU has been signed with IOGA, NLIU, Bhopal and talks for MOU's with other Universities are in progress. The Action plan included to conduct a National Workshop on Cyber Law.
- Human rights Humanitarian Law
 Members were informed about the awareness programs conducted on Human Rights and also the activities to be undertaken.

- The IUD Intellectual Property Rights The Center Head informed the members that School wise, IP awareness program amongst Faculty Members and students of IUD will be initiated shortly once the restrictions of the COVID-19 pandemic are lifted and students are in the campus. It will dwell upon the ownership interests and rights.
- Centre for Intellectual Capital and Institutional Building (CICIB) The IUD Research Cell has now been renamed as 'Centre for Intellectual Capital and Institutional Building' (CICIB). The objective is to increase the number of publications in ABDC/Scopus/UGC journals of repute.
- Institution Innovation Council (IIC) The Centre Head informed the members that the Center is now fully functional. Upcoming activities included an online lecture by Ms. Nhu Chung from Vietnam University on Export - Import Business opportunities Between Vietnam & India, Jointly organized by UEL and IIC.
- Centre for Excellence Alternative Dispute Resolution Cell (CEADR) The Centre Head presented the ction plan for the year January December 2021.
- Career and Skills Development Center (CSDC). The Centre Head listed the achievements and activities undertaken by it. 67% students of MBA have been placed and by Mid-February the remaining students from IBS will be placed.

Suggestions by the Chairperson

The following suggestions were given by the Chairperson for the Centers:

The IUD Case Research Center (CRC)

The Chairman suggested that the Case Study teaching methodology being followed in IBS, be extended to ILS. Emphasis of Case Study teaching methodology should be taken up by Law faculty members; as in all courses they take the help of Case Laws in their lectures. Cases should be published by the ICFAI Law School.

Center for Intellectual Capital and Institutional Building (CICIB)

It is mandatory that each Research Scholar has to publish at least one paper per Semester in ABDC/ Scopus/ UGC Journal. The School Journal should also be included in the briefing of the Center Head and the record of the published journals from January to December 2021 be presented.

Artificial Intelligence and Machine Learning(AI)

The Chairman queried about the functionality and the impact of virtual labs. The projects undertaken by the Center should be taken beyond the Defense sector and projects by students be undertaken for the

upliftment of society. Timelines for transferring AI and Machine Learning technology to the students and how the 3D Printers technology will benefit IUD.

The Registrar informed the members that he would be taking a lecture on AI for faculty members and students.

Cyber Law Cell (CLC)

The Chairman informed the members that grants for any projects undertaken by any of the Centers will be provided by the university, depending on the feasibility of the project.

It should include the details of the activities conducted their Crystal Report with geotagged photographs.
