

ADMISSION POLICY & SELECTION PROCEDURE

For Admission into the Ph.D. Program (Full-Time/Part-Time) The ICFAI University, Dehradun

1 Introduction

- 1.1 The ICFAI University, Dehradun (IUD) was established under the provisions of The ICFAI University Act 2003 (Act 16 of 2003) enacted by the State of Uttarakhand.
- 1.2 The University is recognized by the University Grants Commission under Section 2(f) of UGC Act, 1956.
- 1.3 This policy shall be called the "IUD ADMISSION POLICY & SELECTION PROCEDURE-2024" (IUDAPSP-2024) for admission to Doctor of Philosophy (Ph.D.) awarded by IUD.
- 1.4 The ICFAI University, Dehradun offers admission into the Ph.D. programme on both the basis i.e. full-time and part-time.
- 1.5 While every effort has been made to ensure that the information contained in this document is accurate at the time of publication, all matters that it covers may be subject to change without notice. IUD reserves the exclusive right to change or withdraw, without notice, any statement in this document.

2 Eligibility criteria for admission to the Ph.D. Programme

The following are eligible to seek admission to the Ph.D. programme for all the schools of IUD (Management, Science and Technology, Law and Education):

2.1 Candidates for admission to the Ph.D. programme shall have successfully completed:

A 1-year/2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed.

OR

A M.Phil. degree from any recognized university with at least 55% marks in aggregate or an equivalent grade in a point scale (wherever grading system is followed).

OR

A 4-year/8-semester bachelor's degree programme with at least 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed.

2.2 Candidates in the final year of their master's programme who expect to complete all their qualifying degree requirements before a specified date indicated by the IUD can apply for admissions. For short-listing purposes, their performance till the preceding semester/year would be considered but their admission would be provisional, subject to their meeting the minimum eligibility criteria after their final qualifying examination results are announced.

For any other national or international degree, the scale will be interpolated accordingly. An equivalence committee will be constituted by the VC to consider applications other than covered under above Clause (2.1, & 2.2). The minimum eligibility criteria indicated above is only an enabling clause. Ph.D. Admission Committee (hereafter referred to as PAC) constituted by the VC may fix higher criteria at the time of shortlisting keeping in view the number of candidates, minimum background to cope with the program.

Part-time candidates are required to submit a 'No Objection Certificate' on a proper letterhead from the competent authority of the organization in which he/she is presently working clearly stating that the candidate is permitted to pursue Ph.D. on a part-time basis and his/her official duties permit him/her to devote sufficient time for completion of coursework and carry out doctoral research.

3 Intake for Ph.D. Admission 2024-25

The admission into the Ph.D. program will be taken under following three categories:

- **Category-1:** M.Phil. degree holders with 55% marks **OR** JRF/NET/GATE/CEED and similar national level tests qualified
- **Category-2:** Candidates with certificate of admission to Ph.D. only issued by UGC-NET/Joint CSIR-UGC NET for June-2024 examination.
- Category-3: Candidates other than Category 1 & 2.

4 Procedure for Admission

- 4.1 The candidates desired to seek admission to Ph.D. Programme at IUD shall apply for the same on the prescribed Application Form by a due date announced by IUD.
- 4.2 The applications will be scrutinized by the Research and Development Cell, IUD under the guidance of Ph.D. Admission Committee-2024 (PAC-2024) constituted by the Vice-Chancellor.
- 4.3 Candidates who belongs to Category-3 are required to appear in entrance test named 'IUD Research Entrance Test 2024 (IUDRET-2024)'.
- 4.4 IUDRET-2024 will be an objective type test of 50 questions to be attempted in 2 hours. The entrance will be held offline at IUD Campus only on the prescribed date. However, for applicants outside India, the university may conduct entrance examinations and interviews in online mode.

- 4.5 Qualifying marks in the entrance test (IUDRET-2024) will be 50%. If a candidate fails to obtain the qualifying marks, he/she may not be called for interview.
- 4.6 After the IUDRET-2024 written test, list of shortlisted candidates for the interview will be displayed on IUD website.
- 4.7 An interview/viva-voce for both category will be organized by the IUD wherein the candidates are required to discuss their research interest/area through a presentation before a duly constituted committee. Interview will be conducted on the prescribed date at IUD campus only.
- 4.8 The selection of qualified candidates will be on the following criteria :

- 4.11 The last date of fees submission is taken as last date of admission in the Ph.D. Programme.


