The program structure and syllabus of LL.M. two year Programme was adopted with the following suggestions.

- i. It was suggested that the Learning outcome should be in tune with the Programme objective and course objectives.
- ii. Each unit should cover standard number of sessions.
- iii. The compulsory subjects should have four credits.
- iv. Based upon the credits of each course the number of lectures should be conducted.
- v. In the course Corporate Taxation, the topic on 'Goods and Service Taxes' should also be included.
- vi. The course on Insolvency Law should be renamed as Bankruptcy and Insolvency Laws in first semester.
- vii. The course on Commercial Banking should be renamed as Commercial Banking and Insurance Laws in the third semester.
