- 1) The proposal for starting one year LL.M. program with specialization in Criminal Laws from the academic session 2025-2026 was approved and the expert members gave the following suggestions:
 - Course to be renamed as Principles of Criminology, Penology & Victimology in place of Penology & Victimology: Treatment and correctional philosophy of Offenders & Collective Violence (Semester I).
 - More emphasis should be laid on how Forensic Sciences helps in investigation.
 - Change title of Course as Crime Investigation & Forensic Science in place of Crime Investigation and Forensics. In this paper include one chapter on Cyber Crime and Cyber security (Semester II).
 - Mention program objectives and program outcomes.
 - Ethics should be a part of Research Methodology.
 - It has to be a five credit course (L-T-P:4-1-0), with a total of 60 sessions.

2) Any other item if required shall be discussed.
